As part of its mission to support India's decarbonisation journey, Advait has strategically forayed into Green Hydrogen, Solar, Fuel Cell and Battery Energy Storage Systems (BESS). Collaborating with leading global players, we've secured advanced technology transfers in alkaline electrolysis, PEM fuel cells, and energy storage solutions, enabling us to design and deliver innovative, scalable systems for hard-to-abate sectors.

Our pioneering microgrid-based Green Hydrogen Plant (300kW)—India's first—demonstrates the integration of alkaline electrolysis with fuel cell systems, producing 70 kWh of clean power for decentralized applications. Building on this success, Advait has partnered with KP Group to deliver a 1 MW Green Hydrogen Project in Gujarat, featuring open-architecture, high-purity hydrogen and oxygen generation for diversified industrial use cases.

Advait's renewable energy portfolio is strengthened by its allocation of 300 MW under PLI Scheme Phases I & II, positioning us as a key enabler of India's target of producing 5 MTPA green hydrogen and becoming self-reliant in clean energy manufacturing.






Growing Order Book


